

**MOTORCYCLE RIDE/EVENT REGISTRATION & RELEASE FORM**

**“Kick Start Your Heart” Motorcycle Run**

The undersigned (*on my own behalf and on behalf of my heirs, personal representatives, successors and assigns*), for and in consideration of the opportunity to participate in this run/event hereby releases all of the following parties: **OKALOOSA GAS DISTRICT** (*“the District”*) an Independent Special District of the State of Florida, **COASTAL POWER SPORTS, INC.**, **THE BLOCK**, the **AMERICAN HEART ASSOCIATION**, **PERRY’S RESTAURANT** in Niceville, **BURGER BARN** in Mossy Head, **HELEN BACK** in Crestview, **BIKER BURGER** in Ft Walton Beach, **SMOKEHOUSE RESTAURANT** in Ft Walton Beach and any other public entity, their owners, officers, board members, employees, staff, volunteers, sponsors, agents, representatives and other participants of this event, all hereby known as “Released Parties” as to this motorcycle run/event, from any and all claims, actions, demands, suits, attorney fees, expenses, rights and causes of action of any kind whatsoever, either individual, joint or several which I now have or later may have resulting from, arising out of, or in connection with my participation in **“KICK START YOUR HEART” MOTORCYCLE RUN**, a fund raising event for the American Heart Association.

This Release extends to any and all claims I or my passenger may have or may have against the Released Parties, whether such claims result from negligence on the part of any or all Released Parties with respect to this run/event or with respect to the conditions, qualifications, instructions or procedures under which this run/event is conducted or from any other cause. I understand that this means that I agree not to sue any or all of the Released Parties for any damage, destruction and/or loss of use of my property or any death or injuries to myself during or in connection with this run/event.

I certify that I have no known physical or mental impairment that may affect my safety or the safety of the other participants, spectators, guest, staff, sponsors or management. I am experienced in and familiar with the operation of motorcycles and that the vehicle I use is in a safe operating condition. I fully understand the risks and dangers inherent in motorcycling. I am voluntarily participating in this run/event and I expressly agree to assume the entire risk of any accident or personal injury, including death, which I might suffer as a result of my participation in the run/event whether such risk results from in any way to the partial or the sole negligence of any or all of the Released Parties.

I understand that the Released Parties accept no responsibility for loss of or damage to my personal belongings including my motorcycle (*regardless of whether or not it is trailered.*) Further, I certify that I am not under the influence of any narcotic, alcohol, inhalant, stimulant, altering substance or any other drug, legal or illegal, that may impair my understanding or judgment and that I will not at any time during the run/event operate my motorcycle under the influence of any narcotic, alcohol, inhalant, stimulant, altering substance or any other drug, legal or illegal. I will operate my vehicle in a lawful and courteous manner and I will willingly depart from the run/event if so directed by run/event staff, volunteers or sponsors.

For the purpose of implementing this Release, I expressly acknowledge that this Release is intended to include all claims which the parties do not know or suspect exist in their favor at the time of the execution hereof, including any other state statute which would otherwise may serve to limit the scope of this Release and indemnification.

**RELEASE & REGISTRATION - READ BEFORE SIGNING**

By signing this Release, I certify that I, and my passenger, are an adult of at least 18 years old and that I (we) have read this Release and fully understand it and that I (we) am not relying on any statements or representations of anyone released thereby and it is my responsibility to have motorcycle liability insurance, and to hold a valid drivers license with a proper motorcycle endorsement.

This form must be completely filled out and submitted for registration *before* or *at the run departure site* to participate in the ride. I, the undersigned, assume the responsibility that contents are complete and correct.

Additionally, by signing this Release, I (we) give permission for the free and uncompensated, by any form or method, use of my (our) name, nicknames, images, likenesses, photographs, digital or electronic image or video, broadcast, telecast, computer transmission, print, radio, recording or voice media of any type, form or medium.
